MORE THAN WOMEN & GENDER DIVERSE YOUTH HAVE BEEN TARGETED BY

ONLINE HATE HAVE WITNESSED

YOUTH WITH DISABILITIES ARE 70% MORE LIKELY TO DIRECTLY EXPERIENCE ONLINE HATE


